The Seller hereby accepts a **non-refundable** deposit in the amount of

whelped / expected to whelp on / around:

The Buyer understands that said deposit is **fully non-refundable**. The Buyer assumes all responsibility for any and all events that may occur which could prevent the Buyer from following through with the final completion of this puppy purchase. The Buyer understands if a deposit is being made on a puppy from a litter not yet whelped or bred, the Seller has no control over the number of puppies or genders produced. If in the event gender request can not be met in this litter then the Buyer agrees this deposit shall be put toward a puppy either of the opposite gender from this litter or a puppy from a future litter of same or different parents. This also applies in the event the Dam does not cover in a mating. Once the deposit has been paid, the remainder of the balance worth £450 must be paid to the Breeder on or before the puppy reaches the age of 7 weeks old. If the money isn't paid by the 7th week age of the puppy, the agreement becomes null and void and the Breeder retains the deposit unless otherwise agreed.
